Furusato Industries, Ltd. has announced today the following outcome of the purchase of its own shares in the market based on the resolution made at the meeting of the Board of Directors held on November 4, 2009, under Article 156 of the Corporation Act of Japan, as applied pursuant to Article 165, Paragraph 3 of the Act.

1. Period of Purchase: From December 1 to 31, 2009
2. Type of shares: Common stock of Furusato Industries, Ltd.
3. Total number of shares purchased: 79,400 shares
4. Total cost of purchase: 39,546,700 yen (excluding commissions)
5. Method of purchase: Purchased on the Osaka Securities Exchange
